2. I expressly agree and promise to accept and assume all of the risks existing in this activity. My participation in this activity is purely voluntary, and I elect to participate in spite of the risks.

I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless THE GILA RANGERS from any and all claims, demands, or causes or action, which are in any way connected with my participation in this activity or my use of THE GILA RANGERS equipment or facilities, including any such Claims that allege negligent acts or omissions of THE GILA RANGERS
